## *About Woodlawn Country Club*

Woodlawn Country Club was chartered in 1914 and plans were drawn up for the clubhouse and the first nine holes which were completed in 1916. The swimming pool was completed in the 1930s. With the Woodlake Encampment nearby, Woodlawn was a place for families to come and enjoy a game of golf. During the fifties, the clubhouse featured a dinner club with French-style table service. An additional nine holes was opened in 1965 to make Woodlawn a competitive 18-hole golf course. Woodlawn Country Club is family owned and operated by lifetime residents of Grayson County and offers its facilities for family entertainment.

## *Types of Memberships Available*

Initiation Fee .....None

Full Membership .....\$150.00 month plus tax – for Residents of Grayson County. Membership entitles Family to unlimited use of the Club’s Facilities.

Non-Resident Full .....\$130.00 month plus tax – for persons residing outside Grayson County. Unlimited use of the Club’s Facilities.

Social Membership .....\$55.00 month plus tax for Clubhouse Privileges Only.

Corporate Membership.....Memberships are available depending on the number of participating members. Please contact the Woodlawn Office at 903-893-9657 for a quotation of dues.

In order to purchase alcoholic beverages at Woodlawn Country Club, one must be a member of the Woodlawn Lounge. A yearly fee of \$7.50 for lounge dues will be billed in February. Also, please note that all alcoholic beverages consumed at Woodlawn Country Club must be purchased at the Clubhouse. You cannot bring your own alcoholic beverages onto the premises.

Dues are subject to change at the discretion of the Club Management. There are no seasonal memberships. members who drop out to rejoin in the spring will be assessed a penalty.

Cart shed space is available for your personal carts. Shed rent is billed twice a year in June and December and is non-refundable.

Dues are billed in advance and are payable by the 10th of the month. Accounts not paid by the end of the billing cycle are subject to a late charge of 1.5%.
